The board discussed the 20-day exemption in the regulations. Tacking options and a possible regulation change will be reviewed in the future.

The suggestion of allowing anonymous complaints was tabled until a later date.

The board also had a brief discussion on grace periods for temporary licenses. Ms. Coyer motioned to remove 201 KAR 39:040 Section 3(2) from the regulation. Mr. Hamilton seconded the motion. The motion carried.

Chairman Drury asked the Board Administrator to send out an email to see which interpreters want to be added to a directory.

The board briefly discussed paid internships.

Ms. Grabau informed the committee she and Chairman Drury had discussed several regulations and forms that needed to be updated. Ms. Grabau and the board will look further into the issue before action is taken.
