NEW BUSINESS

The Board, along with the guidance of Tony Cotto and Carson Kerr, began the continuation of review and revision of the Kentucky Administrative Regulations for the Kentucky Board of Interpreters for the Deaf and Hard of Hearing. They proposed the following revisions:

39.070- Section 1: Rewording of (B), (C), (D), (F); (F) Strike the words “or better”

Section 2: (1) (2) Strike Consecutive; (3) Strike; (4) Reword

Section 3: Possibly Strike Mentor and replace with Supervisor; (3) Strike 20 & replace with 5.

39.080- Strike due to merging into full licensure.

39.090- Section 1: (1) Strike total & replace with minimum; (2) Strike; (3)(4) reword

Section 2: Board develop an orientation by 2021 or 2022 that would be a condition for initial application and must do to be supervisor; (3) 6 hours ethics for temporary

Section 3: Reword. (1)(A) Strike; (2) reword- Strike A, B, C, D

Section 4: (1) (3) Strike

Section 5: Strike and imbed into license requirements

Section 6: Strike

Section 9: Mirror temp. License- 39.070

Section 10: (1) Minimum 15 within 12mo.

39.100: Clean up

A motion was made by Donna Lawlor to schedule another special meeting for October 11, 2019 at 9:00am to noon, with no lunch provided, to continue regulations review and revision, Statute Requests, & Board Member Resignation. Motion, seconded by Kelli Sanchez, carried.
