The ASLPI requirement on the Temporary Licensure Application form should read 3.5 instead of 4.0 until the regulatory changes take effect. Mr. Jones is working on this change to the regulation. Ms. Walls to change application form to reflect the current 3.5 ASLPI requirement.

- a. Moratorium of RID's tests: KCDHH representatives gave an update to the board regarding the RID moratorium. Ms. Spiro made a motion to establish an ad hoc committee under KRS 309.304 Section 8 to investigate further testing options for licensure. Mr. Hamilton seconded the motion. Motion carried unanimously. Ms. Walls to issue letter to all licensees regarding this issue.
- b. Mr. Hamilton made a motion to send a letter to the Governor asking for Mr. Hurdich's resignation due to his relocating out of state. Seconded by Mr. Drury. Motion passed unanimously.
